Decision of the Dispute Resolution Chamber

passed in Zurich, Switzerland, on 29 January 2020,

in the following composition:

regarding an employment-related dispute
between the parties

Decision of the Dispute Resolution Chamber

1. The claim of the Claimant, Derrick Sasraku, is partially accepted.
2. The Respondent, Club Africain, has to pay to the Claimant, **within 45 days** as from the date of notification of this decision, the amount of USD 79,201 plus interest as follows:
 - a. 18% interest p.a. as from 1 August 2019 until the date of effective payment on the amount of USD 65;
 - b. 18% interest p.a. as from 16 September 2019 until the date of effective payment on the amount of USD 16,000;
 - c. 18% interest p.a. as from 2 October 2019 until the date of effective payment on the amount of USD 357;
 - d. 18% interest p.a. as from 1 October 2019 until the date of effective payment on the amount of USD 3,000;
 - e. 18% interest p.a. as from 1 December 2019 until the date of effective payment on the amount of USD 118;
 - f. 18% interest p.a. as from 2 December 2019 until the date of effective payment on the amount of USD 13,774;
 - g. 18% interest p.a. as from 16 December 2019 until the date of effective payment on the amount of USD 16,000;
 - h. 18% interest p.a. as from 1 January 2020 until the date of effective payment on the amount of USD 3,000.
3. The Respondent has to pay to the Claimant the amount of USD 450 corresponding to a flight ticket from Tunis to Accra.
4. The Respondent has to pay to the Claimant interest as follows:

- a. 18% interest p.a. as from 1 August 2019 until 18 October 2019 on the amount of USD 2,935;
 - b. 18% interest p.a. as from 1 September 2019 until 18 November 2019 on the amount of USD 3,000;
 - c. 18% interest p.a. as from 1 November 2019 until 13 December 2019 on the amount of USD 3,000;
 - d. 18% interest p.a. as from 1 December 2019 until 13 December 2019 on the amount of USD 2,882;
 - e. 18% interest p.a. as from 1 August 2019 until 9 August 2019 on the amount of USD 20,000;
 - f. 18% interest p.a. as from 2 October 2019 until 17 October 2019 on the amount of USD 20,000.
5. The Respondent has to pay the Claimant compensation for breach of contract in the amount of USD 47,038 plus 18% interest p.a. as from 24 January 2020 until the date of effective payment.
 6. Any further claim lodged by the Claimant is rejected.
 7. The Claimant is directed to inform the Respondent, immediately and directly, preferably to the email address as indicated on the cover letter of the present decision, of the relevant bank account to which the Respondent must pay the amounts plus interest mentioned under points 2. to 5. above.
 8. The Respondent shall provide evidence of payment of the due amount plus interest in accordance with points 2. to 5. above to FIFA to the e-mail address psdfifa@fifa.org, duly translated into one of the official FIFA languages (English, French, German, Spanish).
 9. In the event that the amount due plus interest in accordance with points 2. to 5. above are not paid by the Respondent **within 45 days** as from the notification by the Claimant of the relevant bank details to the Respondent, the Respondent shall be banned from registering any new players, either nationally or internationally, up until the due amount is paid and for the maximum duration of three entire and consecutive registration periods (cf. art. 24bis of the Regulations on the Status and Transfer of Players).
 10. The ban mentioned in point 9. above will be lifted immediately and prior to its complete serving, once the due amounts plus interest are paid.

11. In the event that the amount due plus interest in accordance with points 2. to 5. above are still not paid by the end of the ban of three entire and consecutive registration periods, the present matter shall be submitted, upon request, to FIFA's Disciplinary Committee for consideration and a formal decision.

Note relating to the findings of the decision (art. 15 of the Rules Governing the Procedures of the Players' Status Committee and the Dispute Resolution Chamber):

A request for the grounds of the decision must be received, in writing, by the FIFA general secretariat **within 10 days** of receipt of notification of the findings of the decision. Failure to do so within the stated deadline will result in the decision becoming final and binding and the parties being deemed to have waived their rights to file an appeal.
