## **PROPOSED ROADMAP FOR AMPUTEE FOOTBALL IN GHANA**

A. Formation of a seven-member Normalization Committee with the responsibility to manage the National Amputee Football Team towards the World Cup; Members of the Committee:

- 1. REPRESENTATIVE FROM THE NATIONAL PARALYMPIC COMMITTEE – CHAIRMAN (PROPOSAL)**
- 2. REPRESENTATIVE OF THE MINISTRY FOR YOUTH AND SPORTS – MEMBER**
- 3. LAWYER - MEMBER**
- 4. JOURNALIST – MEDIA RELATIONS / MEMBER**
- 5. 2 REPRESENTATIVES OF THE MINISTER OF YOUTH AND SPORTS**
- 6. REPRESENTATIVE FROM THE NATIONAL SPORTS AUTHORITY- MEMBER**

### **Responsibilities of the Committee:**

- Management of the national team, before and during the 2022 World Amputee Football tournament in Turkey in October.
- Formation of a technical team to scout, select and prepare players to form the national team.
- Prepare and submit a realistic budget through The International Game Committee to cover the cost of preparation and actual participation in the tournament.
- Identify and solicit for additional funds through sponsorship.



- Recommend to the Ministry of Youth and Sports the number of players and officials to represent the country in the tournament.
- Prepare and submit a report to the Ministry, on the activities of the Committee and the team's participation in the tournament, 21 days after the tournament, and undertake any task related to the tournament.

B. To bring sanity into sport and afford players the opportunity to develop and practice the sports without hindrance,

1. The National Paralympic Committee of Ghana (NPC) and National Sports Authority (NSA), with the supervision of the Ministry of Youth and sports would be responsible for all Amputee Football activities and related matters in Ghana until all outstanding issues are resolved.

2. Entirely new normalization committee with specific terms and conditions as stated above would be responsible for Ghana's participation in the World Cup in Turkey.

3. Neither Ghana Amputee Football Association nor Ghana Amputee Football Federation (the two feuding parties) and their respective executive members will be involved in Amputee Football and related matters until further notice.

4. The NPC-GHANA and NSA in collaboration with the normalization committee are tasked to liaise with Confederation of Africa Amputee Football Federation (CAAF) and World Amputee Football Federation (WAFF) to resolve issues concerning relevant documentation of membership and registration, outstanding world cup matters, and all fees owed and payable to CAAF and WAFF.

With immediate effect the NPC-Ghana is instructed to settle all outstanding fees including this year, 2022.

5. The Ministry of Youth and Sports in consultation with NPC, NSA and the Normalization Committee will work out modalities for a National
